

Session Information

Two full days with Nelrod's Vicki Brower will present Public Housing fines, fees & deposits, How to successfully do applicant / tenant orientations, as well as Effective interview skills & techniques, along with Denials, terminations & hearings.

A **Section 8 Roundtable Discussion**, meet with the Rental Assistance Committee *on Tuesday afternoon*

Essentials for Commissioners is for new and veteran board members as well as executive directors on *Monday and Tuesday.* This training offers a solid overview of legal responsibilities. Understand your PHA policies and how to monitor them, as well as the relationships between E.D. and staff. What do you need to know about voucher utilization, how to avoid lawsuits. improvements as well as VAWA and Capital Fund final rule.
